## THE ACTIVITIES OF THE INSTITUTE OF NOTARIES IN UKRAINE CONCERNING THE PROTECTION AND EXERCISE OF THE RIGHTS AND FREEDOMS OF PERSONS IN THE WAR CONDITIONS

The purpose of notarial activity is to protect the rights and legitimate interests of citizens and legal entities by notaries performing notarial actions on behalf of Ukraine provided for by law, notaries help ensure the implementation of legislation, protect

the rights and freedoms of citizens, and to ensure legal security in the conditions of the war in Ukraine. The notary institute is a key body, which combines public-law and private-law aspects in the context of protecting the rights and freedoms of citizens. Notary is aimed at providing legal support to the population, thus contributing to the support and strengthening the rights and freedoms of man and citizen through the performance of notarial acts. The activity of notaries in the conditions of war is very important to ensure legal protection and restoration of property rights of internally displaced persons. They provide assistance in solving problems, which are related to the loss of documents, property management in the absence of a person and the need for legal protection. Notaries can work in temporarily occupied territories or in war zones, providing legal assistance to citizens in difficult conditions in wartime. This assistance may include processing documents for travel abroad or confirming family ties. Notaries can also help citizens understand the new legal realities, providing information on changes in legislation related to martial law. They advise on the preparation of the necessary documents, such as applications for obtaining the status of an internally displaced person or power of attorney, and help to understand how the new rules may affect the rights and obligations of citizens. Notaries also provide advice on the protection of property rights, registration of inheritance, conclusion of contracts and other legal acts. They also inform citizens about their rights and the possibilities of legal protection in case of violation of rights, including court appeals procedures and other legal actions. So, the notary institution in Ukraine demonstrates a high ability to adapt and introduce new technologies and work methods under martial law conditions. This helps to preserve legal certainty, protection of citizens' rights and ensuring access to notary services even in the most difficult conditions.

Legal assistance in war conditions provides that notaries can work in temporarily occupied territories or in war zones, providing legal assistance to citizens who are in difficult conditions. This includes, for example, processing documents for traveling abroad or confirming family ties. Notaries can also provide information support on legal issues that arise in connection with martial law, helping citizens navigate the new legal realities. In the conditions of war, there are often changes in the legislation concerning the legal regime of property, evacuation, social benefits, etc. Notaries provide citizens with up-to-date information on such changes, helping them understand how the new rules may affect their rights and obligations. Martial law complicates the process of drawing up legal documents. Notaries provide advice on the correct filling and submission of necessary documents, such as applications for the status of an internally displaced person, powers of attorney, wills and other legal acts. Citizens often do not know how to act in the various legal situations that arise as a result of hostilities. Notaries help to understand the procedures related to the protection of property rights, registration of inheritance, conclusion of contracts and other legal issues. Notaries can inform citizens about their rights and the possibilities of legal protection in case of violation of their rights. This includes information about going to court, filing complaints with relevant authorities, obtaining legal aid, etc.

A separate important aspect is support in social security matters. Notaries can help citizens understand issues related to social security, such as receiving pensions, benefits, subsidies and other social benefits. The Institute of Notaries in Ukraine is adapting to the conditions of martial law, introducing new technologies and work methods. For example, the development of electronic notary allows us to continue work even in difficult conditions.

The Institute of Notaries in Ukraine demonstrates a high ability to adapt and implement new technologies and work methods in the conditions of martial law. This helps preserve legal certainty, protect the rights of citizens and ensure access to notary services even in the most difficult conditions. In particular, the introduction of electronic notaries allows one to perform notarial actions remotely, which is extremely important in the conditions of restrictions on movement and evacuation. The use of electronic signatures and digital platforms ensures security and efficiency in working with documents, reducing the risk of loss or forgery. In addition, notaries actively cooperate with government agencies, which allows for the integration of their systems and provides quick access to the necessary information, which is critical for the protection of property rights of citizens. Also important is the role of notaries in providing advice and legal support to internally displaced persons who face numerous legal problems due to the loss of housing and property. Informational support and legal consultations help citizens navigate complex legal issues. Thus, the notary institution in Ukraine not only adapts to new conditions, but also actively promotes the protection of citizens' rights, supporting the stability of the legal system in the country in wartime conditions.
