CHALLENGES AND PROSPECTS OF EUROPEAN INTEGRATION OF UKRAINE: ANALYSIS OF HUMAN RIGHTS LEGAL REGULATION

The protection of human rights, as a legal value of the EU, has a primary ideological significance, because it is used to form, direct and justify some areas of activity and condemn others. In the conditions of Ukraine's European integration, commitment to the legal values of the Union, improvement of its own human rights protection system should become important geopolitical and socio-cultural tasks for our country, since according to the criteria for joining the EU, only a state with an appropriate level of observance of human rights and fundamental freedoms can become a full member of the European Union [1].

The process of European integration in Ukraine includes deep political, economic and social integration into European structures, demanding reforms in various areas. The Association Agreement between the European Union and its Member States, of the one part, and Ukraine [2], the other part is one of the key mechanisms containing obligations regarding the protection of human rights and the principles of legal statehood for Ukraine. EU integration covers various sectors, including aspects of human rights and intellectual property. However, it is important to consider that integration in different sectors may differ in scope and level of implementation. In the context of Ukraine's path to European integration, there is a need to analyze issues related to the legal regulation of human rights to freedom of movement, which is recognized as a means of development and resolution of social conflicts [3].
